## Validated Ministries in the Presbytery of Long Island A.04.03 Policy

The intent of a validated ministry process is to support creativity and the "doing of new things" while also conforming to G-2.0503. An active member... may be engaged in a ministerial calling consonant with the mission of the presbytery in an organization, agency or institution in which this church has no official participation....before entering upon such service the minister shall request permission of the presbytery of membership... If the presbytery grants the permission, such permission shall be subject to review and renewal annually.

Ultimately a minister serving in a validated ministry continues in direct relationship with the COM and the Presbytery. His or her gifts and experiences are to be shared with the larger body and celebrated by that body.

Criteria for ministry validation:

- 1. The ministry shall be in line with the mission of the Presbytery. (G-2.0503)
- 2. The ministry shall adhere to the essentials of the Reformed faith and polity as expressed in the *Book of Order* and the *Book of Confessions* and in conformity with the mission of God's people in the world as set forth in Scripture. (G-2.0503)
- 3. The ministry makes active and effective use of the biblical and theological training that is required for ordination. (G-2.0501)
- 4. The ministry shall exercise pastoral care to those for whom its staff are responsible. The ministry shall serve Christ and humanity, strengthen the church and equip it for service to the human community. (G-2.0501)
- 5. Those involved in validated ministry outside a congregation shall participate in the worship of a local congregation, in their presbytery, and in ecumenical relationships and shall be eligible for election to the higher governing bodies of the church and the boards and agencies of those governing bodies. (G-2.0503a5)
- 6. Those engaged in validated ministries shall be accountable to the Presbytery. (G-2.0503)

Ordinarily, the Committee on Ministry will validate the following ministries:

- 1. Chaplain, pastor and/or Clinical Pastoral Educations supervisor/leader in a health care, educational, armed services or penal institution.
- 2. Teacher of religious studies in an accredited secondary school, college, university or seminary.
- 3. Teacher of any subject, or member of the administration or staff, at an accredited educational institution related to the PC(USA) or to another Christian church or denomination with whom the PC(USA) is in correspondence.
- 4. Staff member of another Christian church or denomination in correspondence with the PC(USA), an interdenominational agency or an ecumenical shared ministry.
- 5. Mission co-worker, fraternal worker, or volunteer in mission, as validated by the PC(USA) or by another Christian agency
- 6. Minister serving a congregation of another Christian church or denomination with whom the PC(USA) is in correspondence.
- 7. Staff member of an organization or interest group whose purpose is to support and advocate for particular points-of-view within the PC(USA).

Process for validating a ministry:

1. The applicant will complete the validated ministry application (see attached) and submit it to the Committee on Ministry (COM).

2. COM will consult with the applicant regarding the details of the application and the responsibilities of a member of Presbytery engaged in validated ministry.

3. Validation for the ministry shall be for the calendar year. COM will review the validation annually and make a determination regarding its continuation.
