<u>Committee on Ministry Elder Patricia Francis (complete report Appendix D - pp 147-149)</u> Compensation Packet 2024

The Presbyterian Church (USA) ratified an amendment to its Book of Order's section G-2.0804 (TERMS OF CALL), mandating a minimum of 12 weeks of paid family leave for called and installed pastors in congregations. The 2024 Compensation Package will be updated to reflect the change.

G-2.0804 Terms of Call

The terms of call shall always meet or exceed any minimum requirement of the Presbytery in effect when the call is made. The session shall review annually the minister's terms of call and shall propose for congregational action (G-1.0501) such changes as the session deems appropriate, provided that they meet the Presbytery's minimum requirements. The call shall include **provision for a minimum of twelve weeks paid family medical leave and** participation in the benefits plan of the Presbyterian Church (USA), including both pension and medical coverage, or any successor plan approved by the General Assembly.

Executive Presbyter Search Committee *Elder Maria Studer*

The Search Committee thanked everyone who attended the cluster Zoom meetings. The conversations and responses have been organized into a report and reviewed. They were pleased to see that the Presbytery as a whole was looking for similar things with the new Presbyter. The information was then used to fill out the Ministry Discernment Profile (MDP). The MDP has been uploaded into the Church Leadership Connection, and they are currently reviewing the matched Personal Discernment Profile.

<u>Treasurer</u> Charlaine Apsel (report Appendix E - pp 150-151)

Budgeting and Finance Committee Elder Ellen Gove (Budget Appendix F - pp 152-154)

The Budget and Finance Committee moved the approval of the 2024 budget. No second was required. The Treasurer answered questions from the floor.

The Presbytery spoke about its declining per capita income since 2019. A question was raised whether the decline was due to churches not paying their per capita or the decline in membership.

Report of the Treasurer Presbytery of Long Island Stated Meeting – September 30, 2023

Although the PRC has been part of the Presbytery since 2014, and I have been the Presbytery bookkeeper for the last 6 years, there is still much I can learn about the financial organization of the Presbytery.

Here are a few general thoughts about what the Treasurer's job is:

- The Treasurer should have the 30,000-foot view but understand the minutia.
- My job is to explain the finances of the Presbytery so everyone understands.
- The Presbytery is a service organization. It exists to help every person and congregation succeed.
- The budget should clearly show what the Presbytery's priorities are.
- Transparency is my goal.

Some numbers from the years of the pandemic

Per Capita Income

2019 - \$578,732

2020 - \$246,744

2021 - \$225,912

2022 - \$200,765

What does Per Capita pay for?

- A percentage of Per Capita goes to the PC USA and some to the Synod of the Northeast.
- It pays for the salaries and benefits of the Presbyter, Stated Clerk, Administrator, Treasurer, and Bookkeeper.
- It pays for the building expenses, including the renovation of the West Islip Church and the moving expenses.
- The Insurance bill includes property coverage for the West Islip office space, the Church and Manse in East Moriches, and the Glenwood Life Center and Manse. We also pay for liability on the Central Church and manse.
- Per Capita also pays for Committee expenses, Boundary Training, the Resource Center, Presbytery Meetings and Presbytery Days, the Vital Congregations program, and Churches that require help.

There are programs of the Presbytery that are supported by Specific Designated Funds, things like the New Church Development program, Salary Supplement, and Candidate grants. There are also programs paid out of the Mission fund, Salt and Light, and the Hispanic ministries.
