14. The following **letter was sent to Rev. Colby Rohde** on February 1, 2026, via mail and email:

Dear Rev. Rohde,

Peace and grace to you. I pray that you are doing well and have had a good start to the new year.

I am writing on behalf of the Commission on Ministry (COM). As communicated to you in 2025, the COM revisited the validation of your ministry with the Island Christian Church. That ministry originally was validated by the COM on January 10, 2023, with the stipulation that you provide your terms of call annually to the COM and remain an active member of a presbytery committee.

As a presbytery, we have not received your terms of call, a response to our annual requests for reports from pastors, or any communication from you regarding your ministry. Therefore, as of its meeting on March 11, 2025, the COM decided to no longer validate your ministry with Island Christian Church. Additionally, you have not participated in meetings of the presbytery or its committees or in a congregation of the presbytery or in correspondence with the PC(USA), which are expectations of members-at-large (G-2.0503a, b).

This letter is to remind you that Book of Order section G-2.0508 governs a minister of the Word and Sacrament no longer engaged in a validated ministry or fulfilling the criteria for membership-at-large. I will follow the process outlined in G-2.0508 and report to the presbytery again this year that you are no longer engaged in a validated ministry or fulfilling the criteria for membership-at-large. After three years (this is the second year of notification), the presbytery may delete your name from the roll of membership.

The Presbytery of Long Island of the Presbyterian Church (USA) held a Stated Meeting at the First Presbyterian Church, 330 Main St, Northport, NY 11768, on Saturday, November 15, 2025, with 115 attendees, including 64 voting members. Ida Rosario in Spanish, and an Opening Prayer led by Rev. Immanuel Bae in Korean, at 9:35 AM.

The next Stated Meeting of the Presbytery will be held on Tuesday, February 3, 2026, at 6:00 PM on Zoom

The Presbytery moved to convene **Presbytery Day with Dr. Corey Schlosser-Hall and Rev. Samuel Son** from the PC(USA) Office of Innovation, who led a workshop, "The Future of Ministry," exploring emerging trends and tools for congregational growth and innovation.

In **Session 1: The Future will be More Mixed, Looped & Augmented**, participants examined three major dynamics shaping the church's future: a mixed economy that combines traditional giving with social enterprises and creative partnerships; a two-loop ecology where established and emerging faith communities collaborate and share wisdom; and AI augmentation, which is transforming creativity, ethics, and theological reflection in ministry.

Session 2: Innovation & Acceleration introduced practical tools such as the Two Loops Model to assess a congregation's current dynamics and the Good Futures Accelerator, a discernment process encouraging creative thinking about partnerships, property use, and new revenue sources. Churches nationwide are using these models to strengthen mission and sustainability.

Finally, **Session 3: Shaping an Imaginative Future** invited participants to stretch their creative thinking through futurist Jane McGonigal's exercise, "100 Ways Anything Can Be Different in the Future." The session encouraged moving beyond incremental improvement to bold reimagining, highlighting that discomfort and curiosity can lead to breakthrough ideas and renewed ministry vision.

No Items for Action

Committee on Preparation for Ministry (CPM) met via Zoom on November 4, 2025

Liaison reports were received regarding Stephanie Castlen, Samantha Kendrick and Mylika Selah (formerly Slaughter).

The committee met with Bob (Robert) Caputo regarding his chaplaincy plans.

An update as to Keith Davis' progress was given. He will graduate from the CRE certificate program in December. A meeting is scheduled for January.

Dolly Mohan completed the CRE program at Dubuque. Her certificate is on file. A meeting is scheduled for January.

Carolyn Corwith is in the CP program through San. Francisco Presbytery. The recommendation to the program was forwarded on her behalf in November.

General conversation - After a brief conversation, it was decided that timeframes need to be established for a person to remain under care. A conversation is planned with Louisville for suggestions, and a report will be given in the new year.

A brief discussion took place regarding Sharon Austin Barrow's inquiry to transfer her ordination from the Methodist Church in the Caribbean and the Americas (MCCA). We are awaiting a response from Dianna Wright, director of Ecumenical Relations.

Committee on Preparation for Ministry (CPM) met via Zoom on December 4, 2025

The CPM met with Samantha Kendrick. Samantha is in her 4th year and will be graduating from Columbia in May 2026. Per conversation information on the required training courses and a link to an upcoming informational meeting on upcoming Ordination exams was sent.

Sharon and the CPM as the MCCA is not part of the Formula of Agreement, and the CPM will need to decide which requirements she must meet to transfer membership.

Kerry updated the committee on Samantha Kendrick's request for financial assistance.

Consultation with Keith Davis - Keith shared his sense of call, expressing a desire to continue his business while potentially pursuing full-time ministry after retirement. Presbytery of Long Island Stated Meeting February 3, 2026 - ZOOM

Motion: Approve the attached resolutions for the sale of 7 North Lane, Glen Cove (the church property of the former First Presbyterian Church of Glen Cove).

Motion: Approve the attached resolutions for the sale of 114 Camdike Street, Valley Stream (the manse property of the former Valley Stream Presbyterian Church).

The Trustees met on January 21, 2026, at 6:30 PM, via Zoom.

Present: Rev. Ida Rosario, Rev. Steve Adkison, Elder Bill Phillips, Elder Natasha Hines, Elder Candace Breen Warren, Treasurer Charlaine Apsel, EP / Stated Clerk Kate Jones Calone. Rev. Paul Lent joined the meeting around 7:00 PM.

The meeting opened with prayer.

MSP: Approve the minutes from the November 5, 2025, meeting.

Treasurer Charlaine Apsel shared a year-end Treasurer's report, with Balance Sheet, Profit & Loss, and Budget vs. Actual documents. She reported that the presbytery is in the process of moving funds from Capital One to Chase Bank, with static cash funds to go in the Merrill Lynch checking account. David Haight met with the Enduring Witness Team to help advise them about grant allocations for 2026. The presbytery is at about 83-84% of the per capita received.

MSP: Elect Rev. Steve Adkison as President of the corporation and Rev. Ida Rosario as Vice-President.

The Trustees discussed the following continuing items:

- East Moriches: **MSP: Approved resolutions for the sale of the property.**
- Shinnecock: The session voted to recommend a "stick build" of the manse, and the congregation will vote on that recommendation on February 8th, and they will then search for contractors and estimates.
- Glen Cove: **MSP: Approved resolutions for the sale of the property.**
- Glen Head Manse: Closing on the sale of the manse is scheduled for the end of January.
- Valley Stream: **MSP: Approved resolutions for the sale of the manse property.**

- Collaboration for Christ: Bill P. shared an update from the group, including a contractor list ready to be sent out to churches in the presbytery. CFC meets quarterly. Any recommended contractors should be sent to Bill P. for inclusion on the list.
- Kate reviewed the provision of the new bylaws that outlines the responsibilities of the Trustees.
- Bill P. discussed the shared generator for the presbytery that is stored at Center Moriches and the need for detailed operation and safety instructions for any church that might borrow it. Suggestion to create both written instructions and a video that could be accessed by a QR code on the generator. Discussion about other generators that had been purchased by the presbytery and a need to identify where they are currently being stored.

Enduring Witness Team

In calendar year 2025, Enduring Witness distributed 12 grants, totaling \$153,612.03. In total, we approved the following:

First Babylon - \$5,000 for revitalization of children's ministry following a successful VBS
 Islip - \$18,700 for parish house bathroom and chapel ac/heating repair
 Korean United - \$730 for sign replacements and banners
 Malverne - \$6,000 for manse chimney and boiler pump repairs

Middle Island - \$15,750 for manse mold remediation
Oceanside - \$4,500 for parking lot repairs
Port Jefferson - \$15,000 for website redesign and social media manager
Port Jefferson - \$15,000 for fellowship hall/food pantry repairs and renovations
Setauket - \$25,000 for one year of Open Door Exchange expenses
Shelter Island - \$17,268 for A/C repair/replacement, related ceiling repair for community space
Smithtown - \$12,350 for sound/video equipment upgrade for sanctuary and live-streaming
Southampton - \$13,118.40 towards building upgrades to meet state preschool requirements
Westminster - \$5,195.63 for community outreach program

The committee has seven applications currently in review.

For 2026, Enduring Witness is making \$514,136 available for spending. This number is 25% of the December 31, 2025 balance of the Enduring Witness Fund (1304) of \$2,056,544.01. Enduring Witness has also committed to funding 50% of the new Presbytery position for the next three years. The staff person is expected to be a resource to congregations in much the same way this committee does. As the position is not yet filled, we cannot cite an exact amount for 2026 but estimate \$420,000 will be available for grants.

Grants will be awarded on a rolling basis. Applications received after November 1 will be evaluated in 2027.

Immigration Task Force

The Immigration Task Force continues to meet monthly to discuss how our presbytery can support and stand with our immigrant neighbors and congregation members. They participate in faith-based public actions, recommended to the Shepherding Council the creation of a Immigration Emergency Fund, and provide resources to congregations.

NCD Visioning Team

The New Church Development Visioning Team has been meeting for several months to discern our presbytery's vision for and commitment to new worshiping communities. At its last meeting on January 22, 2026, the Visioning Team reviewed a draft *Presbytery of Long Island Guidelines for New Worshiping Communities*. An updated draft will be presented to the Shepherding Council at its meeting on March 9th. Should the way be clear, the guidelines will then come to the presbytery for approval at its May stated meeting.

Report of the Executive Presbyter
Stated Meeting of the Presbytery – February 3, 2026 Zoom

One year ago, our presbytery approved a new mission statement:

**Guided by the Spirit,
Our Presbytery follows Christ
by partnering with
congregations, communities, and individuals
to embody God’s inclusive love and justice
in an ever-changing world.**

The mission statement was very intentional in talking about “our” presbytery— because it’s all of us together, with God’s help, Christ’s way, and the Spirit’s leading. When so much in the world operates to isolate—to separate us from one another—Christ’s church draws us into relationship, even when it’s messy and challenging. We find each other, in congregations and across our presbytery, and we remember that we’re not alone, because God is with us, and God has given us each other. And then we do our best to follow Christ together. In our Presbyterian way of doing things, that looks like groups of Christ-followers coming together to sit around a table (or in a Zoom meeting!) and asking what God wants us to do—and then being accountable to each other as we live out God’s call.

So together over the past year lots and lots of people have gathered in different ways to pray and talk about taking seriously who we say we are as a presbytery on Long Island. Our Shepherding Council reads our mission statement together at the start of every meeting, and our Moderator team has been modeling a partnership with each other that seeks to lead with collaboration and a deep commitment to prayer.

We’ve restructured our committees to work together more relationally and intentionally, including adding a Social Witness Committee; and our Nominating Committee has worked tirelessly to call people to our connectional ministries. We’ve adopted new bylaws, reorganized our funds to match our asset policy, and ensured that there is trust and transparency about how the proceeds of property sales or other assets are used. The Trustees and several Administrative Commissions do the hard work of discerning together with congregations about the stewardship of their properties.

Our new Enduring Witness Team decided intentionally to help resource the ministries of our congregations not through creating burdensome grant applications but through listening to how the Spirit is moving in our congregations, starting with a \$1000 catalyst grant to every congregation in our presbytery. And our Commission on Ministry is focused first and foremost on building relationships, with the hope that our congregations feel companionship in both their joys and their challenges. The New Church Development Committee has been discerning together as well, meeting regularly for several months to pray for our existing NCDs and also to develop a renewed vision for New Worshiping Communities, which will come before our presbytery in May.

We spent our November Presbytery Day on imagination, led by staff from our PC(USA) Office of Innovation. And this year, shaped by our Personnel Committee, we'll start a search for a new Associate Presbyterian who will focus on congregational vitality, especially in partnership with smaller congregations that would welcome additional resourcing and support in our ever-changing world.

Our presbytery has tremendous leaders. Pastors care for all of us, especially in our hardest days, and then stand up in the pulpit each week and proclaim God's word in very complicated times. More and more ruling elders are also sharing their gifts for preaching, and we've supported that important ministry through a venture with our sibling presbyteries in New Jersey, offering classes in preaching and presiding at the table for ruling elders. (What a tremendous joy it has been to hear the sermons developed in those classes!) The Committee on Preparation for Ministry is helping people feeling called to ministry from an ever-widening variety of paths, including several commissioned ruling elders.

There's much more I could lift up—people who are serving across our presbytery (as well as at the Synod and GA levels), congregations that are engaging in very meaningful ministry with the communities around them, faithful worship and prayer and study that happens each week here in our presbytery. But I do want to mention and thank in particular the staff in our congregations who are providing critical ministries that enable all of the ministries of the church: office administrators, sextons, Sunday morning childcare providers, music leaders, bookkeepers, Christian educators, and more. In our presbytery, of course, it is Laurie Vu and Charlene Apsel who are the most essential, committed, and faithful partners in ministry for all of us.

Let me close by saying this: our mission statement articulates our commitment to embody God's inclusive love and justice. And friends, there is no more urgent or important time for our presbytery, our congregations, and each of us to take seriously that commitment. As the hands and feet of the Christ who *always* stood with those outside the centers of power, we need to stand with and for those in our communities who are living in fear. Our immigrant neighbors—which includes many people who worship each week in pews of our Presbyterian congregations—need to know and see that we embody God's inclusive love and justice. (And if you need help with wondering where to start, reach out to our very faithful Immigration Task Force.) Those who are afraid of how they'll make ends meet because of rising health care costs or how to feed their families need to know and see that we embody God's inclusive love and justice. Those who are afraid of stepping foot in a church because they worry it's a place of judgment and division need to know and see that we embody God's inclusive love and justice. I commend to you the Statement of the Shepherding Council, linked on the front page of our website, that was presented to our Presbytery this past May. And I pray that together we strengthen each other with courage and hope in building God's beloved community here on Long Island.

Thank you for being part of our presbytery. You are loved and appreciated beyond words. Thanks be to God for giving us each other.

**Glen Cove Administrative Commission Report
for the February 3, 2026, Stated Meeting of the Presbytery of Long Island**

The Glen Cove Administrative Commission has not met formally since the last Presbytery meeting, as the sale of the properties is now in the hands of the attorneys. Executive Presbyter Rev. Kate Jones Calone has been keeping us updated on the progress via e-mail.

The **members** of the Glen Cove Administrative Commission are: Rev. Steve Adkison (Shelter Island, Chair), Elder Frank D'Andrea (Deer Park), Elder Betty Ann McConaghy-Roel (Glen Cove), and Rev. Ann Van Cleef (Greenlawn). Deacon Steve Wasilchuk (Oyster Bay) serves as a consultant, and Rev. Kate Jones Calone (Executive Presbyter) staffs the commission.

In addition, the following people attended meetings at various times to lend their expertise: Charlaïne Apse (Presbytery Staff), Elder Steve Bodden (Deer Park, property marketing consultant), Joe Gutlieber (FPC Glen Cove Treasurer), Pastor Lana Hurst (Glen Cove), and Renato Matos (Attorney).

The following is a summary of progress taken from Rev. Kate's e-mails with her permission.

Church building:

- We have received the deposit and signature page from the buyer (The Apostles Church) for the sale of 7 North Lane with a purchase price of \$2.5M and \$1M due at closing. The Trustees have approved the sale and holding a note for the remaining \$1.5M should the buyer be unable to secure other financing, with payments of \$7,000/month.
- Purchaser is aware and in the purchase & sale agreement acknowledges and agrees to accept the property subject to any landmark designation by the City of Glen Cove.
- The necessary court petition will be filed shortly after the February 3rd Presbytery meeting, at which the final resolution will be moved by the Trustees.
- Together with our lawyers, Rev. Kate attended the most recent meeting of the Glen Cove Landmarks Commission.
- We have had to do some critical maintenance work over the past few weeks--updating the locks on the building, replacing one of the boilers, and servicing the hot water heater.
- The Seventh Day Adventist Church that uses the building is aware of the sale process and is in conversation with the buyer, the Apostoles Church.
- After the Presbytery meeting, we'll communicate with the remaining employees (the sexton and the bookkeeper) about a likely timeline for concluding their services.

Glen Head Manse:

- We received court approval for the sale of 1 William St. in Glen Head. A closing was held at the CBMS (our attorneys) Syosset Office on Wednesday, January 28, 2026.
